

North County Celtic Queen Pageant Rules and Regulations



The *North County Celtic Queen* serves as the Official Hostess of the *North County St. Patrick's Day Parade & Festival*, presented by the **Vista Village Business Association (VVBA)**. Her duties will be to preside at the opening breakfast, ride in the parade, assist with contest judging, assist with the awards ceremonies, perform any other duties as required, and participate in all publicity appearances for future events. The Queen is required to attend all events on St. Patrick's Day, as directed by the Pageant Director and / or the VVBA.

- ❖ Contestants in the 2012 *North County Celtic Queen Pageant* must comply with the following **Rules & Regulations**. Failure to comply will result in the forfeiture of the title, crown, sash, and all prizes.
- ❖ The contestant must be between the ages of 17 - 24 on March 17, 2012. Contestant must have been born a female, be single, never been married or have had a marriage annulled, never have given birth nor be pregnant or ever have been pregnant, and must be of good moral character.
- ❖ Contestant must not have been convicted of a crime nor be under investigation for any reason.
- ❖ Contestant must be a legal resident of North San Diego County, outside the boundaries of the City of San Diego, this includes the areas known as Bonsall, Camp Pendleton, Carlsbad, Escondido, Fallbrook, Oceanside, Rainbow, San Marcos, Valley Center, and Vista. Contestant must provide a copy of her birth certificate and driver's license, California ID, or school ID to the Pageant Director.
- ❖ Contestant must not have appeared nude, partially nude, or in a manner that can be construed as nude in any photo, movie, video, publication, or event, and agrees not to do so during her reign.
- ❖ Providing false information on this entry form or provided to the pageant or pageant director in any manner will disqualify the contestant from participation in the *North County Celtic Queen Pageant* and will result in the forfeiture of the title, crown, sash, and all prizes.
- ❖ *North County Celtic Queen* may compete in other pageants.
- ❖ Contestants will be judged on interview, personality, public speaking, poise, beauty of face and figure, sportswear, and formal gown. Contestant is responsible for all costs associated with her participation in the pageant.
- ❖ The Pageant Director and the VVBA must approve all appearances. All transportation costs will be the sole responsibility of the winner.
- ❖ Contestant understands that the winner may not use her title to endorse or advertise for any service, product, or business without the expressed and written consent of the Pageant Director and the VVBA.
- ❖ Contestant understands that the Pageant Director and the VVBA reserve the right to disqualify a contestant at anytime for any infraction of the rules & regulations. Contestants will exhibit good sportsmanship during all phases of the pageant and all events.
- ❖ Contestant releases, for purposes of publicity and without compensation, the use of any photograph, video, or audio taken by the pageant staff, the Pageant Director, the VVBA, and / or local news media.

I agree to the Rules & Regulations as set forth above, and I further agree to hold harmless the Pageant Director, the VVBA, The Vista Chamber of Commerce, the City of Vista, and any or all representatives of same from and against all liability from damages or injury, which might occur as a result of participation in any activity connected to this pageant.
